We would like to reassure you that we will never rent or sell your information to anyone under any circumstances.

Data security

We have implemented security measures to prevent your personal information from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. Our employees, subsidiaries, affiliated companies, third party service providers and other trusted businesses will only process your data on our instructions.

The basis for which we process your information
